It applies to the old **E15 Reid Vapor Pressure** "one pound waiver" in White House Renewable Fuel Standard negotiations. And, it applies to the **CAFE** (Corporate Average Fuel Economy) mid-term review and California's role in setting mileage and pollution standards.
