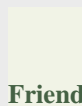

Although the [E15](#) waiver has been lifted (and it looks like New York will make its sale legal in that state), the new rule can still limit retail sales due to "[sub-sim](#)" issues that Urban Air Initiative explains. And public comment was taken on the new [renewable volume obligation \(RVO\)](#) numbers. South Dakota leads on efforts to get [E30](#) understood and accepted.

Then attention turns to President Trump's order for 31 [small refinery exemptions](#) and resulting "demand destruction" that will result if non-exempt refiners aren't required to make up the difference. Senator Chuck Grassley had some strong words to express his assessment of the situation.

[CAFE/SAFE](#) and California regulations remain in the news. State/region-oriented [Low Carbon Fuel Standard](#)-type strategies are bubbling up.


