RenovaBio is a program to expand biofuel production in Brazil with the objective of contributing to the reduction of GHG emissions in the country. It is based on predictability; environmental, economic and social sustainability and compatibility with fuel market growth. The seminar includes presentations from experts of the policy, including a discussion of emission reduction certificates (CBIOs).

The group are visiting the U.S.A. as part of the USDA's Cochran Fellowship Program and are being hosted by the University of Missouri. During the visit the group will receive information on U.S. renewable fuel policies, and the modelling techniques used to analyze them. They will meet with groups involved in the industry with the aim that opportunities for U.S. involvement in the Brazilian market are identified and explored.
